

**WAIVER OF LIABILITY AND ASSUMPTION OF RISK**

1. This is a release of liability. All persons under 18 years of age must have their parents or guardians sign for them.
2. I understand that kayaking can be a dangerous sport and can result in serious and permanent physical injuries and/or death.
3. I understand that the river is a natural force containing hydraulic pressures and currents that can overturn my kayak, pin me under water against rocks, bushes or trees and result in my drowning. In addition, I understand that I may hit my head against various obstacles or fail to exit from my kayak resulting in my serious injury or drowning.
4. I EXPRESSLY AGREE TO ASSUME THE RISK OF HARM ARISING FROM THE NEGLIGENCE RECKLESS CONDUCT OR BREACH OF WARRANTIES OF BACKDOOR SPORTS LTD., ITS OWNERS, OFFICERS, EMPLOYEES AND.
5. I AGREE TO RELEASE FROM LIABILITY AND WAIVE ANY AND ALL CLAIMS FOR PHYSICAL INJURY AND/OR PROPERTY DAMAGE THAT I MAY HAVE AGAINST BACKDOOR SPORTS, LTD., ITS OWNERS, OFFICERS, EMPLOYEES, AGENTS AND SERVANTS RESULTING FROM THEIR:
  - a) Negligence and/or breach of warranties,
  - b) Negligent failure to assist, negligent advice or negligent conduct,
  - c) Negligence while in vehicles owned or leased by Backdoor Sports, Ltd.,
  - d) Negligence while on property owned or leased by Backdoor Sports, Ltd.,
  - e) Implied or express warranties or warranty for a particular purpose for furnishing and supplying defective or unsuitable equipment to me.
6. I AGREE TO WAIVE ANY CLAIMS I MAY HAVE AGAINST BACKDOOR SPORTS, LTD., ITS OWNERS, OFFICERS, EMPLOYEES, AGENTS AND SERVANTS RESULTING FROM THE NEGLIGENCE BY ME TO OTHERS WHILE PARTICIPATING IN KAYAKING ACTIVITIES COMTEMPLATED BY THIS AGREEMENT.
7. I AGREE TO WAIVE ANY CLAIMS I MAY HAVE AGAINST BACKDOOR SPORTS, LTD., ITS OWNERS, OFFICERS, EMPLOYEES, AGENTS AND SERVANTS RESULTING FROM THE NEGLIGENCE OF OTHERS TO ME WHILE PARTICIPATING IN KAYAKING ACTIVITIES CONTEMPLATED BY THIS AGREEMENT.
